**The New Mexico Equine Liability Law**

There are inherent risks to participants and observers involved in all activities with equine animals due to the propensity of an equine animal to kick, bite, shy, buck, stumble, bolt, rear, trample, be unpredictable or collide with other animals, objects or persons. New Mexico state law provides that no person, corporation or partnership is liable for personal injuries to or for the death of a rider, (or other participant) that may occur as a result of the behavior of equine animals while engaged in any equine activities. In consideration of the privilege of joining the NMMBA and participating in events and activities sponsored by the NMMBA, its officers, membership or donors/supporters, at Shaking Wind Ranch or other locations, members, and rider, guests, or other participants agrees to engage in the equine activity at his/her own risk and agrees to hold NMMBA, Shaking Wind Ranch, its owners, managers, trainers and equines, and all NMMBA members and guests harmless in the event of injury, loss, or death to persons or animals or losses of property resulting from participation in NMMBA or equine related activities.
